Definition/Botanical Origin: The volatile oil obtained by steam distillation of the fresh twigs, leaves and sometimes the fruits of Corymbia citridora (Hook) K.D. Hill L.A.S. Johnson aka Eucalyptus citriodora (Fam Myrtaceae).

3. HAZARDS IDENTIFICATION:

4. FIRST-AID MEASURES:
