### 4. First aid measures

### 7. Handling and storage

### Handling

: Put on appropriate personal protective equipment (see Section 8). Eating, drinking and smoking should be prohibited in areas where this material is handled, stored and processed. # Recommended monitoring procedures

#### **Hygiene measures**
